From a strategic lens, HDH is focused on ensuring that we deliver safe and effective health care that is responsive to the needs of our region; that we strengthen partnerships and community engagement; ensure the financial sustainability of the hospital and finally, support the current and future health care teams. It is through these strategic focuses that HDH will strive to uphold our mission, vision and values.

Your Commitment as a Board Member:

Our Board is comprised of a maximum of 12 people who offer a diverse experience and perspective. Each member of the Board is asked to commit to a three (3) year term, renewable for a maximum of four (4) consecutive terms. All applicants are interviewed and successful applicants are provided a full orientation including the role of board members, board policies and by-laws, the format of board meetings, information about the hospital's strategic plan, structure, programs and services, hospital funding, legislation and a hospital tour.

It is expected that Board members participate in at least one of the Board committees (Finance/Audit & Property, Nominating, By-Law, Public Relations), the Quality Governance & Risk Management of the Whole and all scheduled Board Meetings. Board Meetings are held 9 times a year on the 4th Tuesday of the month; there are no meetings scheduled in December, July and August. Quality Governance & Risk Management meetings are held immediately following the Board meeting.

It is expected that no member will be absent for more then two (2) Board meetings without sufficient cause within the September – June Board year. Virtual/teleconference options are available when Board members are unable to attend in person.

A Little Bit About the Hanover & District Hospital:

HDH works with its partners to provide a full range of primary acute care hospital services and selected secondary services to meet the needs of the population of Hanover and the surrounding rural townships. HDH provides the people we service access to the care they need through 24/7 Emergency Department, Acute Care Unit (inclusive of medical/surgical beds, multipurpose ICU and RCU beds), inpatient Physiotherapy Program, Surgical Services Department, Family Centred Birthing Unit, Hemodialysis Unit, Palliative Care Services and Flex Clinic.

Access is provided within the organization to Community Mental Health and Addiction Services, Chaplaincy Services, Grey-Bruce Diabetes, Home and Community Support Services, Home and Community Care SWLHIN and the Hanover Family Health Team.

HDH has been accredited with Exemplary Status in three consecutive surveys. (2013, 2017, 2021) This is the highest level awarded by Accreditation Canada and reflects that our Board, staff, volunteers and physicians strive to surpass the fundamental requirements of the accreditation program.
